Permanent Makeup / Microblading

Am I A Good Candidate:

Permanent makeup **IS NOT** recommended for any client who are or have:

- Pregnant or nursing
- Diabetic Type 1 (must have Dr. consent)
- Undergoing Chemotherapy (consult your doctor)
- Viral infection and/or diseases
- Epilepsy
- A Pacemaker or major heart problems
- Had an organ transplant
- Skin irritations or Psoriasis near the treated area (rash, sunburn, severe acne, cold sores, shingles, impetigo, pink eye, etc)
- Sick (cold, flu, etc)
- Had Botox less than 2 weeks
- Lupus
- Hepatitis B/C
- AIDS
- Active Vitiligo
- Severe Rosacea
- Blood Disorders: Sickle Cell, Hemophilia
- Keloid Formation
- Mental Disorder
- Accutane (must be off for 6 months)
- Steroids (must be off for 6 months)

Before Care

- **DO NOT** work out the day of the procedure as it will expand your pores. It is recommended not to sweat (heavily) for the first 7-10 days after the procedure. Sweat is salty and it will prematurely fade or blur the pigment.
- DO NOT tan or have a sunburned face.
- DO NOT take Aspirin, Niacin, fish oil, Vitamin E or Ibuprofen 24 hours before the procedure.
- No alcohol or caffeine on the day of the procedure.
- Please note that you will be more sensitive during your menstrual cycle.
- Waxing treatments should be performed 2-3 days before your appointment
- IPL laser hair hair removal should be performed no less than 2 weeks prior to your appointment
- Electrolysis treatments should be performed no less than 5 days prior to your appointment
- Eyebrow or lash tinting should be done 2 days prior or 2 weeks after your appointment

Pre-Procedure Instructions Eyebrows: Avoid tweezing, waxing, electrolysis, and coloring your brows for two weeks prior to the procedure. This will allow your technician the most flexibility to achieve optimal results.

We offer several different options of eyebrow pigmentation lasting from several months to several years. (Microblading vs. traditional micropigmentation). We offer hair strokes, hair strokes with shading and fully shaded brows. Your specialist will discuss the best options for you depending on your skin type, lifestyle, desired results and desired maintenance.

Rest assured, we use the best tools and the best pigments in the industry.

Eyeliner:

- Do not wear contact lenses during or immediately following your eyeliner procedure. Remember to bring your glasses. You may resume wearing your contact lenses as soon as your eyes return to their pre-treated condition.
- The use of Latisse® must be discontinued at least 3 months prior to your eyeliner procedure. Latisse® produces an inflammatory reaction in the skin, which causes excessive pain and bleeding. If you use Latisse®, your eyeliner will not take properly.
- Do not use other growth stimulants such as RapidLash®, or RevitaLash® for at least one week prior to or one week after your eyeliner procedure.
- Lash extensions must be removed completely before your eyeliner procedure. If you have lash extensions, we will not be able to do your eyeliner. Lash extensions pose a danger to your eyes during the micropigmentation procedure.

Lips: If you have any history of cold sores, fever blisters, or herpes simplex, you must contact your physician to obtain and take the proper prescription medication to prevent such outbreaks for at least 4 days before and after the procedure. Many physicians prescribe 12 capsules of 500mg Valtrex. Follow your physician's instructions. You may also experience a lot of swelling that could take several days to recede.

Micropigmentation is a process. Two or three sessions may be required to achieve the desired results. It is not uncommon to lose up to 70% of the color after the first session.

Topical Anesthetic Advice

- Allergic reaction can occur from any anesthetic used during the procedure. If you do suffer from an allergic reaction, you should contact your doctor immediately. Allergic responses may show through as redness, swelling, rash, blistering, dryness and potential other symptoms.
- Numbness we cannot accept responsibility if the area to be treated does not respond to the numbing cream. Each individual is different according to their skin types. Some clients report the area to be completely numb, while other may experience some discomfort.
- Procedure for microblading or other PMU treatments, a Lidocaine numbing gel is used. The anesthetic is placed over the treatment area for 15-30 minutes the carefully removed prior to treatment depending on the procedure. As a result of the treatment, you can expect to experience some redness/swelling that can last 1-4 days. You should always follow your post procedure advice and after care for best results.

After Care

- First day (dry, normal skin): Rinse with warm water and neutral soap, without stretching the skin. Circle gently on the eyebrows until clean skin is felt under the fingertips. After rinsing use a thin layer of protective ointment. The first rinsing process should take place 30 minutes after treatment. Use ointment or dry heal as directed.
- Next 3 days apply thin layer of ointment 3 times daily after normal facial hygiene.
- Avoid 2-3 weeks after treatment applying powder, makeup, creams with active ingredients over the eyebrows, bathing in public water, profuse sweating, sauna, solarium, etc.
- The area may appear uneven, dry, itchy, tender, red and irritated. This is all normal. DO NOT PICK AT THE SCABBING. The symptoms will dissipate each day and vary by individual.
- Color will fade/soften anywhere from 30-50%. At touch up session we will fine tune any areas that have faded. Healing is specific to each client.
- Semi-permanent or PMU enhancements normally require multiple application sessions. To achieve best results you will be required to return for at least one perfection session 4-8 weeks after initial appointment.
- Everyone's skin heals differently and most clients develop patchy areas or the appearance of them after the first treatment. It is important to understand that this is a two-part process and the touch up treatment will complete the procedure.
- It is important to remember that no two sides of the face are the same. Perfection is our goal but eyebrows are sisters, not twins.

Eyebrows will appear darker and bolder due to natural scabbing and healing for the first 10 days. This is very common for all permanent makeup procedures.

Restrictions

- Retinol/Retin-A must be discontinued 7 days prior to procedure. (It will cause the skin to bleed).
- Injections (Botox, Radiesse, JuvaDerm, Voluma, etc.) must be done 2 weeks before or 2 weeks after procedure.
- Chemical peels and laser treatments may not be done within 60 days before or after procedure.
- The use of Latisse® must be discontinued at least 1 months prior to your eyeliner procedure (it creates an inflammatory response, causes excess bleeding and prohibits the eyeliner from healing well).
- Sunburned or Suntanned skin is damaged skin and therefore will cause excessive bleeding. We CANNOT work on sunburned or suntanned skin.
- You cannot expose the area to the sun for 30 days before or after procedure.
- Do not schedule this procedure within one week prior to a water vacation. Stay out of steam rooms, saunas, hot yoga, swimming pool, etc. for one week following procedure.
- Avoid working out and sweating profusely for 1 week post procedure. (sweat will prevent pigment from healing into the skin)
- Avoid alcohol and caffeine 1 day before procedure to minimize any oozing, bleeding or swelling. Do not take aspirin, ibuprofen, niacin, fish oil or vitamin E 3 days prior to procedure unless medically necessary.

OUR POLICIES are as follows:

CLIENT-ONLY IN THE PROCEDURE ROOM: Though a friend or family may accompany you to your appointment, we have learned it is best that they do not sit-in on your procedure. It is important the artist is able to have their full focus on you, the client. Friends and family tend to be a distraction for both the client and artist.

CHILDREN, TODDLERS AND BABIES. Though we love children, toddlers and babies, we must kindly ask that you do not bring them with you to your appointment. Unfortunately, they are a distraction to the artist, as well as the other guests having services at Wink. Thank you for your understanding.

CANCELLATION POLICY:

Micropigmentation/PMU is a time-intensive service. In booking your appointment, we are reserving a designated amount of time specifically for you. We require a \$100 deposit in order to reserve this time for your appointment.

If you need to cancel for any reason, we require that you cancel at least 72 hours prior to the start of your appointment time so that we may be able to offer this time to another client.

If your appointment is cancelled with less than 72 hours' notice (or in the case of a no-show), you will forfeit your \$100 deposit and a new deposit will be required to reschedule your appointment.

Follow-up appointments: A \$100 balance is left due for the follow-up appointment to a new/initial procedure when it is done within 10 weeks of the initial procedure. However, in the case of a cancellation with less than 72 hours' notice or a no-show, the follow-up is considered forfeited and any following appointments will be charged as a touch-up appointment of \$250.

PERFECTION SESSION: will be performed no more than 10 weeks from initial visit. Beyond that a \$150 fee will be applied to your balance.

TARDINESS: Please plan to arrive at Wink 15 minutes prior to the start of your appointment. You will need to complete a consent and medical intake form before you arrive. We want to make sure you have time to make yourself comfortable before the start of your appointment.

In the event that a client is more than 30 minutes late, the procedure may be cancelled, and deposit or additional fees may apply, as we are not able to sell this time to another client.

RIGHT TO REFUSE TREATMENT: Though it is extremely rare, we reserve the right to refuse treatment for the following reasons: • Undisclosed skin condition (including sunburn/suntan) • Under the influence of drugs or alcohol • Any behavior which, in the opinion of the artist or Wink, might compromise the artist's or Wink's ability to work safely and comfortably toward the desired results, or might disrupt other clients.

You will be given detailed after-care instructions at the time of your procedure. Please call or email us with any other questions you may have.
